By signing this waiver of liability statement, I agree for myself, and anyone entitled to act on my behalf, to **HOLD HARMLESS, WAIVE AND RELEASE** Bounce Fit Club, its owners, employees, agents, successors or insurers from any responsibilities, liabilities and claims for any and all bodily injury, including death, that I may suffer as a direct or indirect result of my participation in a fitness program and/or event through Bounce Fit Club whether at Bounce Fit Club facility, at home, or elsewhere.
